#### **NSW MARINE PARKS-LETS GET IT RIGHT**

Since 2000 the recreational anglers of NSW have invested \$60 million of their own money into enhancing recreational fishing in NSW. The money has been used to restructure the commercial fishing industry, enhance fish stocks, protect threatened species and enhance recreational fishing opportunities within NSW.

The recreational anglers of NSW contribute \$500 million to the NSW economy annually. Currently within NSW, two new marine parks have been legislated and the recreational anglers of NSW are being asked to comment on proposed sanctuary zones within the parks.

The recreational anglers of NSW support the establishment of marine parks within NSW.

The recreational anglers of NSW support the protection of biodiversity within marine parks.

The recreational anglers of NSW are asking the NSW Government to get it right and not rush the process that has historically taken 2 years to complete. No recreational fish stocks are under threat of collapse within NSW, why rush the process?

Any proposed sanctuary zones needs to be qualified with independent scientific research that includes stock assessments of any proposed sanctuary zone. Any proposed sanctuary zone must also provide safe and easy access for rock and beach anglers in all weather conditions. Any proposed sanctuary zones needs to provide access to transient species such as highly migratory pelagic fish species such as tuna, salmon, marlin and bait stocks.

If any recreational fish species are identified as being threatened or at risk within a marine park, the NSW Government needs to consider multi-use sanctuary zones as an option. A similar precedent has existed within NSW for many years, with the threatened Grey Nurse Shark. Gear and bait restrictions are used to protect the GNS within critical habitat zones along the NSW coast.

The recreational anglers of NSW are prepared to work with the NSW Government to establish marine parks within NSW.

Safe, sustainable and equitable use of the resources within marine parks is what the anglers of NSW are calling for.
