Jervis Bay Marine Park Zoning Plan Review

The Marine Parks Authority has commenced the review of the zoning plans for Jervis Bay. The current zoning plan for Jervis Bay Marine Park has been in place for five years. A review is now underway to determine whether the plan remains appropriate for meeting the objects of the Marine Parks Act.
